



Running for office as a Libertarian in Michigan is a powerful way to make a difference in your community and promote liberty at every level of government. Our party focuses on encouraging candidates to run competitive campaigns, especially for local offices, where your efforts are most likely to have the greatest chance for success.

The process of running for office with the Libertarian Party of Michigan (LPMI) is outlined in this document. The document is extensive but some steps may not be mandatory. Also, there may be slight variations depending on the office sought.

Candidates are encouraged to start their run for office by joining the LPMI.

1. Nomination Process

Candidates running for partisan office in Michigan receive a nomination for office at a statewide convention or a county affiliate caucus held after the filing deadline for candidates to appear on Michigan's primary ballot and before the date of the primary.

Non-partisan office filers do not require party nomination and will file paperwork directly with their clerk before a primary election; these offices typically have a signature gathering requirement or filing fee. The partisan convention or caucus replaces the primary election where Democrats and Republicans compete. A nomination at a convention puts a Libertarian candidate directly on the ballot in the general election.

It is important to determine the office sought's jurisdiction. If the office is contained in an affiliated county, that county affiliate of the LPMI will hold a nominating caucus for that office. Any office with jurisdiction crossing county lines will be nominated at a Statewide Nominating Convention. Nominating conventions and caucuses take place between the primary filing deadline of the 15th Tuesday before the August primary date and the day before the August primary date.

2. Paperwork

Once a nomination for office is accepted the candidate will need to fill out three forms and turn them in to the appropriate offices within 24hrs. Additionally, once a nomination is accepted the candidate has 10 calendar days to form a Candidate Committee. (A candidate committee is a political committee that is directly established, authorized, or controlled by a candidate running for public office. It is responsible for raising and spending money to support that candidate's election campaign.) After the committee's formation date, the candidate has an additional 10 calendar days to register the committee by filing a Statement of Organization form with their filing official. A person becomes a candidate under the Campaign Finance Act on the date the nomination is accepted. Candidates running for federal office will register their committee with the FEC.

- Certification of Party Nomination
 - o This is not a standardized form. This is a letter signed by either the State Party Chair and Secretary or the local affiliate Chair and Secretary.

- Note: While a candidate is required to file the Statement of Organization for their campaign committee after accepting a nomination, this form can be filed earlier if a candidate is collecting donations and campaigning prior to accepting the nomination.

3. Campaign Finance

The Candidate Committee is responsible for tracking all donations and expenditures for the candidate. Setting up a candidate committee involves several legal and administrative steps. The process varies by jurisdiction, but here's a general guide to establishing and managing one.

Your candidate committee will be established at either the County, State, or Federal Level. The Statement of Organization is the form that establishes the Committee at the County and State level. Each county may have a slightly different process for later campaign finance filings, but the [Statement of Organization](#) will be filed with the county clerk. Once the statement is accepted the campaign finance statements will be turned in to that clerk's office on the schedule linked [HERE](#).

Candidates running for office with a Federal level jurisdiction will register with the FEC. An individual running for a seat in the House or Senate or for the office of U.S. President becomes a candidate when he or she raises or spends more than \$5,000 in contributions or expenditures. It is recommended that the candidate committee establish themselves with the IRS and open a bank account. The Committee representative will apply for an EIN for the committee through the IRS website [HERE](#) or file via mail. The IRS will issue a form SS-4 that establishes the committee. This is usually handled by the campaign treasurer. The bank will require the form SS-4 from the IRS and meeting minutes that state that the person opening the account is authorized to do so by the committee.




